

Enrolment, introductory meeting and the beginning of the academic year 2020/2021

Enrolment is an important event which confirms your status as a registered student of the University. Due to the pandemic circumstances, this year exceptionally you don't need to collect signatures and grades in your index. We already asked student representatives to collect as many indexes as possible at to bring them to our office during July.

[Here is the link](#) to the online enrolment form. You will enter the form using your AAI password (the same one you use to enter your Studomat).

Once you confirm and submit your enrollment form (we will download it from the system), your payment slip (by e-mail) and your index (student representatives will bring your indexes to student office) - you will be enrolled. Please, DO NOT submit your enrollment form if you are still planning to take exams in July/ September 2020.

Once we receive your enrolment form – for us it means that you are done with exams for academic year 2019/2020.

Enrolment schedule:

- ❖ **1st year students – September 10, 11 and 12, 2020**

Enrolment deadline:

- ❖ **2nd year students – September 21, 2020**
- ❖ **3rd year students – September 22, 2020**
- ❖ **4th year students – September 23, 2020**
- ❖ **5th year students – September 24, 2020**
- ❖ **6th year students – September 25, 2020**

Classes start on September 28, 2020 for study years 2-6

Introductory week for newly enrolled students will take place from September 14 until September 18, 2020

Introductory meeting for newly enrolled students will take place on September 17, 2020 – at 11 am – the hall will be posted later

For the first year students classes start on September 21, 2020

Your enrolment is only valid for one academic year at a time.

As part of the enrolment process students are required to abide by the University's rules and regulations. Be so kind and find attached Academic Regulations for Graduate Programs and Disciplinary Measures Policy (also posted at LMS).

Late Enrolments

Enrolments after the prescribed deadline (after 25 September 2020) are permitted only in exceptional cases and will be additionally charged 500 Euro.

Failure to complete enrolment will lead to your exclusion from classes and assessments.

How to enroll

To be fully enrolled, you will need

CONTINUING STUDENTS ONLY:

- your **index – no signatures and grades for 2019/20 are required**
- EU citizens – **“boravišna iskaznica”** (residence card)
- Foreign (non EU citizens) citizens – **“dozvola boravka”**
- Croatian citizens – valid **“osobna iskaznica”**

- passed all the **exams** that are prerequisites for the enrolment in the following year (**gained 45 ECTS in 2019/2020 and a Croatian language course**)

- Free-movers and students participating in Erasmus exchange are **obliged to enroll** under same conditions
 - paid **tuition fee** for the following year (or the first installment if paying in two installments) – **payment slip is obligatory!**

For generation first enrolled in 2019/2020 the cost of study (tuition fee) for the academic year 2020/21 is 12,000 Euro (twelve thousand Euro), payable in a lump sum by September 15 of the respective academic year, or 12,200 Euro payable in two installments (2 x 6,100) prior to the beginning of each semester (by September 15 and February 15).

If the student does not meet the required criteria he/she loses the year, enrolling in the same year according to the Regulation on the Graduate Level of the University of Zagreb, School of Medicine. The tuition fee for repeating the year is the lump sum of 6,000 Euro payable by September 15 of the academic year in question.

For generations first enrolled in 2016/2017, 2017/2018 and 2018/2019 the cost of study (tuition fee) for the academic year 2020/21 is 9,000 Euro (nine thousand Euro), payable in a lump sum by September 15 of the respective academic year, or 9,200 Euro payable in two installments (2 x 4,600) prior to the beginning of each semester (by September 15 and February 15).

If the student does not meet the required criteria he/she loses the year, enrolling in the same year according to the Regulation on the Graduate Level of the University of Zagreb, School of Medicine. The tuition fee for repeating the year is the lump sum of 4,500 Euro payable by September 15 of the academic year in question.

For generations first enrolled before 2016/2017 the cost of study (tuition fee) for the academic year 2020/21 is 7,000 Euro (seven thousand Euro), payable in a lump sum by September 15 of the respective academic year, or 7,200 Euro payable in two installments (2 x 3,600) prior to the beginning of each semester (by September 15 and February 15).

If the student does not meet the required criteria he/she loses the year, enrolling in the same year according to the Regulation on the Graduate Level of the University of Zagreb, School of Medicine. The tuition fee for repeating the year is the lump sum of 3,500 Euro payable by September 15 of the academic year in question.

Enrolments will not be allowed without settling all eventual previous debts to the University as well as paying the tuition fee for the prospective year.

- **NEW:** completed the relevant enrolment **form** available at [link](#)
- **Continuing students who met all the criteria for the enrollment are invited to enroll as soon as possible (even in July). The dates in the enrollment schedule are the LAST dates for the enrollment.**

NEWLY ENROLLED STUDENTS ONLY:

- your **OIB number** (personal identification number). You will get it at the Police when registering your temporary residence in Croatia for the first time or at Tax Administration, Avenija Dubrovnik 32. OIB field is a mandatory field in the inf. system and the enrolment is not possible without it.
- **vaccination record**
- Students who have NOT graduated from a Croatian secondary school:
 - **foreign education qualification recognition issued by** the Education and Teacher Training Agency (**Agencija za odgoj i obrazovanje, AZOO**), **Donje Svetice 38, Zagreb.**
 - **in case you did not apply for foreign qualification recognition at the Agency yet, it could be done with the assistance of our School and in order to do so you should bring all the documents required at** http://www.azoo.hr/index.php?option=com_content&view=article&id=2702&Itemid=92 (**Instructions and Request**)

Please note that the certificate of recognition is the prerequisite for the full enrollment and you will not get your index until the recognition is done.

- Applicants who obtained their university degree abroad and are enrolling into the transition year will have to get their period of study recognized in the Republic of Croatia.

It will be done with the assistance of the school and you will get further directions at the enrolment.

- EU citizens – **“boravišna iskaznica”** (residence card) - as soon as you get it and before December 1, 2020
- Foreign (non EU citizens) citizens – **“dozvola boravka”** - as soon as you get it and before December 1, 2020
- Croatian citizens – valid **“osobna iskaznica”** and **OIB**
- paid **tuition fee** for the following year (or first installment if paying in two installments) – **payment slip is obligatory!**
The cost of study (tuition fee) for the academic year 2020/21
 - is 12,000 Euro (twelve thousand Euro), payable in two installments (2,500 Euro within 10 days from receiving the offer of place and 9,500 Euro by September 15),
 - or 12,200 Euro payable in three installments (2,500 Euro within 10 days from receiving the offer of place, 6,100 Euro by September 15 and 3,600 Euro by February 15).
- completed the relevant enrolment **forms** (you will receive the forms by e-mail)
